

Cornish Probate Records (A - M)

This file contains abstracts of probate records held mainly at the Cornwall County Record Office (CRO). Most of them relate to my own family or to names I am researching.

The abstracts are transcribed from original records at the Cornwall Record Office, from photocopies of original records or from records filmed by the LDS.

For those records where the reference is a volume and page number, details are taken from a register copy at the CRO, rather than from the original will. If you think a will or admon may relate to your family you should consult the original record, which in most cases will be available at the CRO.
